Letter From Todd Kennedy President and Chief Executive Officer, Providence Hospital

Dear Supporters,

During Fiscal Year 2019, Providence Hospital along with the Foundation's support, began multiple projects across our health ministry to provide better access to care to improve the health of our community.

One of the major projects for FY2019 was the construction and opening of our \$4.8 million-dollar Hybrid Operating Room. This new type of OR allows for very intensive case types in a hi-tech surgical environment that allows for minimally invasive heart and vascular surgeries. The Hybrid OR imaging



technology allows for real time body imaging during surgery and is the best of its kind in the Mobile marketplace.

Providence also added a new GI physician to our medical group, Dr. Latasha Henry, who brought with her new capabilities and innovative technology. Dr. Henry now offers to our patients and families the ability to perform Endoscopic Ultrasound procedures which are minimally invasive procedures to assess digestive diseases. With the use of EUS equipment, Dr. Henry can use high-frequency sound waves to produce detailed images of the lining of the walls of the digestive tract and nearby organs to seek out disease states without the need for an open surgery. We welcome Dr. Henry and her family and thank her for joining Providence Health System.

I also want to welcome Dr. Lindsey Beakley who is a Fellow Trained Breast surgeon who also has brought new surgical techniques and equipment to improve our breast program. Dr. Beakley, along with our new Radiation Oncologist, Dr. James Galle are partnering in utilization of our new Linear Accelerator to bring the best in Breast treatments available to battle breast cancer in our community.

Finally, to improve overall campus protection and security and to protect those we serve, a new security monitoring system was installed along with new parking lot and roof cameras to show detailed, live imagines of the state of security on Providence's 200-acre campus. If you feel like you are being watched, it is because you are! At all times our cameras are monitored, and the detail now is more amazing than ever. The new security system and our close partnership with Mobile police, allows a quick response to any potential issue that may arise on our campus.

These are just a few of many projects that occurred in FY 19 to better visitor, patient, and clinician experience here at Providence. All these changes were not without struggle, but the improvements they bring continue to strengthen Providence's abilities to serve our Mobile families.

My thanks go out to each and every patient, friend and associate who has supported Providence Hospital and the Foundation's work. Fiscal Year 2019 was a strong year for Providence. With your support, we look forward with confidence to continuing to deliver the best in patient centered, faithbased healthcare.




