Member Spotlight: Matthew and Karen Cullen

Children learn by example and often inherit your character traits. So what better way to teach them your value of giving, along with the value of a dollar, than by involving them in your philanthropic decisions?

That's just what Matt and Karen Cullen did with their three sons when the family gave a generous gift to St. John Hospital and Medical Center (SJH&MC) in 2011 that led to their McQuade Society membership. The Cullens chose to

support the Neonatal Intensive Care Unit (NICU), where their youngest son had spent three weeks as a newborn.

"It was an obvious choice for us to pick the NICU; we spent a lot of time there when John was born and were incredibly impressed by the compassionate, skilled people caring for the babies," Matt said. "We were offered a menu of priorities that needed support, and we thought it was a good time to engage our boys in philanthropy and show them the importance of giving. We decided to let them select what would be funded with our donation; we gave them an amount to allocate for whatever they thought was important."

After studying the list and having much discussion, the two younger boys wanted to get cribs and incubators for the babies in the NICU. The Cullens' oldest son, who had spent a lot of time in the waiting room waiting for his little brother to come home, thought that comfortable furniture would be helpful to families.

"The boys had fun making the choices; they had to move money around to make the total amount work for what they wanted," Matt said. "It was a great learning experience."

The boys—Matthew, now 18; Ryan, 15; and John, 13—have since been involved in other philanthropic endeavors, including the "I Love Lucy" fundraiser for Lucy Loch, a close family friend, who was treated for Hodgkin's lymphoma at SJH&MC's Meade Pediatric Hematology Oncology Center. The boys volunteered

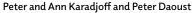

for the volleyball event and raised money to assist Lucy's family who, in turn, donated the proceeds to the Meade Center to help other families.

Matt says the boys' participation in these activities has helped get them engaged in the community and excited about helping others. "And when they have a personal connection to the person or organization they are helping and a belief in its purpose, the experience has more meaning to them," he said.

The same holds true for Matt and Karen.

"St. John is important to us personally and on a broader community level. Our three boys were born here, we've had many trips to the ER as well as all our other health care here," Matt said. "I have a great interest in St. John Hospital and got engaged because I wanted to help an organization that is critically important to our community and has a passion for its mission."

Because of his strong background in real estate and facilities development, Matt was approached to become a member of the St. John Health Foundation Board during the capital campaign for the expansion of SJH&MC. The Cullens feel that giving your time is just as important as contributing financially, so Matt embraced the request and served on the board from 2005 to 2013.

Matt is president and CEO of Rock Ventures, LLC, the entity which provides operational coordination to entrepreneur Dan Gilbert's portfolio of companies and investments. Previously, Matt was a 29-year veteran at General Motors, where he was general manager of economic development and enterprise services.

As founding chairman of the Detroit RiverFront Conservancy, Matt has helped oversee the billion dollar redevelopment of the city's riverfront. In addition, he serves as volunteer president and CEO of the M-1 RAIL streetcar initiative for Woodward Ave. Matt is also involved in many other city initiatives and is on the boards of several community organizations.

Matt's motivation for his strong focus on Detroit is simple. "Detroit is my hometown, I grew up here when it was vibrant, my family and friends are here,



and I want our city to be a thriving place again for our children and those in the future," Matt said.

Between family, work and volunteer obligations, the Cullens receive their health care at SJH&MC, where they now have the advantage of being McQuade Society members.

"While the quality of care is the same high level for all patients, McQuade Society membership gives us an extra level of attention," Matt said. "It's great to be identified as a member and have the personal attention and interaction.
